Background

On December 16, 2013, the Honorable Naomi Reice Buchwald, United States District Court Judge for the United States District Court for the Southern District of New York issued an Order To Approve a Plan of Distribution to Investors in the matter of SEC v. AL-RAYA INVESTMENT COMPANY, and WALEED KHALID AL-BRAIKAN, As Representative Of the Heirs of HAZEM KHALID AL-BRAIKAN and KAMCO. The Plan of Distribution provides that the fund, comprised of disgorged profits, prejudgment interest and civil penalties paid to the Clerk of Court and placed into an interestbearing account with the Court Registry Investment System, approximately \$6,228,728.61 (SIX MILLION TWO HUNDRED TWENTY-EIGHT THOUSAND SEVEN HUNDRED TWENTY-EIGHT DOLLARS AND SIXTY-ONE CENTS), shall be distributed for the benefit of injured investors who purchased the common stock of Textron on April 9, 2009 and/or Harman common stock on July 20, 2009 and have an Eligible Loss Amount as defined by the Distribution Plan.

The Court has appointed Analytics Consulting, LLC as the Distribution Agent to distribute to Textron and/or Harman Investors who qualify under the Court-approved Distribution Plan and Plan of Allocation.

Who is Eligible for Compensation

If you purchased Textron, Inc. common stock on April 9, 2009 and/or purchased Harman International Industries, Inc. common stock July 20, 2009 and have an Eligible Loss Amount as defined by the Distribution Plan of at least \$10.00, you may be eligible for compensation from the Textron, Inc./Harman International Industries Inc. Fair Fund ("Textron/Harman Fair Fund").

Whether you will have an Eligible Loss Amount for which you will be compensated depends on a number of factors, which are detailed in the Plan of Allocation section of the Distribution Plan. You should read the Plan of Allocation in the Distribution Plan in its entirely before filing a claim. A final determination of whether you will receive a Distribution Payment, and the amount, is made by the Court-appointed Distribution Agent.

How to Obtain Compensation
