The *LKQ Corporation* class action lawsuit was filed on behalf of those who purchased or otherwise acquired *LKQ Corporation* ("LKQ") (NASDAQ: LKQ) common stock between February 27, 2023 and July 23, 2025, inclusive (the "Class Period"). Captioned *City of Miami General Employees' & Sanitation Employees' Retirement Trust v. LKQ Corporation*, No. 26-cv-00498 (M.D. Tenn.), the *LKQ* class action lawsuit alleges that *LKQ* and/or certain of its officers and/or directors violated federal securities laws by making false or misleading statements and/or omitted to disclose material information.

### COMPLAINT ALLEGATION SUMMARY:

*LKQ* is a global distributor of vehicle components and replacement parts for the repair of automobiles. In February 2023, *LKQ* announced plans to acquire its competitor, Uni-Select Incorporated ("Uni-Select") and its United States subsidiary, FinishMaster, for \$2.1 billion. FinishMaster offered automotive refinish and painting services throughout the United States, and accounted for approximately 40% of Uni-Select's annual revenue.

The complaint alleges that, throughout the Class Period, Defendants made materially false and/or misleading statements, as well as failed to disclose material facts about the company's business, operations, and prospects. Specifically, Defendants misrepresented and/or failed to disclose that: (1) FinishMaster was losing major customers and market share prior to the acquisition; (2) FinishMaster's business was not only unable to grow, but it would be unable to sustain at all; and (3) as a result of the foregoing, Defendants' statements about the company's business, operations, and prospects were materially false and misleading and/or lacked a reasonable basis at all relevant times.

### **WHY DID LKQ'S STOCK DROP?**

On April 24, 2025, *LKQ* reported that its segment that encompassed FinishMaster had missed its revenue targets by about \$200 million. This revelation saw *LKQ*'s stock price fall by 11.6%. By July 24, 2025, *LKQ* reported that the segment's performance continued to decline, and the company suffered a year-over-year decline of 11%. On this news, *LKQ*'s stock price fell a further 17.8%.

### **THE LEAD PLAINTIFF PROCESS:**

The Private Securities Litigation Reform Act of 1995 permits any investor who purchased or acquired *LKQ* common stock during the Class Period to seek appointment as lead plaintiff in the *LKQ* class action lawsuit. A lead plaintiff is a representative party that acts on behalf of other class members in directing the litigation. In order to be appointed lead plaintiff, the Court must determine that the class member's claim is typical of the claims of other class members, and that the class member will adequately represent the class. Your ability to share in any recovery is not, however, affected by the decision whether or not to serve as a lead plaintiff. Filling out the online form above or communicating with any counsel is not necessary to participate or share in any recovery achieved in this case. Any member of the purported class may move the court to serve as a lead plaintiff through counsel of his/her choice, or may choose to do nothing and remain an inactive class member.
