The *Nano-X Imaging Ltd.* class action lawsuit was filed on behalf of those who purchased or otherwise acquired *Nano-X Imaging Ltd.* ("*Nano-X*") ([NASDAQ: NNOX](#)) securities between March 31, 2025 and April 17, 2026, inclusive (the "Class Period"). Captioned *Katlyn Steele v. Nano-X Imaging Ltd.*, No. 26-cv-07062 (D.N.J.), the *Nano-X* class action lawsuit alleges that *Nano-X* and/or certain of its officers and/or directors violated federal securities laws by making false or misleading statements and/or omitted to disclose material information.

COMPLAINT ALLEGATION SUMMARY:

The complaint alleges that, throughout the Class Period, Defendants made materially false and/or misleading statements, as well as failed to disclose material facts about the company's business, operations, and prospects. Specifically, Defendants misrepresented and/or failed to disclose that: (1) *Nano-X's* purported efficiency gains and increased demand were overstated; (2) the company's production and manufacturing operations were not aligned with demand, which caused significantly increased operating expenses; (3) the company faced increased likelihood of needing to take remedial measure to adjust its manufacturing at significant impairment cost; and (4) as a result of the foregoing, Defendants' statements about the company's business, operations, and prospects were materially false and misleading and/or lacked a reasonable basis at all relevant times.

WHY DID NANO-X'S STOCK DROP?

On April 20, 2026, *Nano-X* announced in its financial results a net loss of \$33.4 million in the fourth quarter. The company went on to disclose that the losses were caused by its inefficient production model that was not aligned with product demand. On this news, *Nano-X's* stock price fell more than 24%.

THE LEAD PLAINTIFF PROCESS:

The Private Securities Litigation Reform Act of 1995 permits any investor who purchased or acquired *Nano-X* securities during the Class Period to seek appointment as lead plaintiff in the *Nano-X* class action lawsuit. A lead plaintiff is a representative party that acts on behalf of other class members in directing the litigation. In order to be appointed lead plaintiff, the Court must determine that the class member's claim is typical of the claims of other class members, and that the class member will adequately represent the class. Your ability to share in any recovery is not, however, affected by the decision whether or not to serve as a lead plaintiff. Filling out the online form above or communicating with any counsel is not necessary to participate or share in any recovery achieved in this case. Any member of the purported class may move the court to serve as a lead plaintiff through counsel of his/her choice, or may choose to do nothing and remain an inactive class member.
