



Smart Digital Group Limited Securities Fraud Class Action Lawsuit - SDM

The *Smart Digital Group Limited* securities fraud class action lawsuit was filed on behalf of those who purchased or otherwise acquired *Smart Digital Group Limited* ("*Smart Digital*") (NASDAQ: SDM) securities between May 5, 2025 and September 26, 2025, at 9:34 AM EST, inclusive (the "Class Period"). Captioned *Dixit v. Smart Digital Group Limited*, No. 26-cv-00296 (S.D.N.Y.), the *Smart Digital* class action lawsuit alleges that *Smart Digital* and/or certain of its officers and/or directors violated federal securities laws by making false or misleading statements and/or omitted to disclose material information.

CASE BACKGROUND:

Smart Digital is a Singapore-based digital marketing, event planning, and software service provider that primarily conducts business through three operating entities: SMART DIGITAL META PTE. LTD.; AOSI PRODUCTION CO., LTD.; and Xiamen Liubenmu Culture Media Co., Ltd. On May 5, 2025, *Smart Digital* completed its initial public offering, selling 1.5 million ordinary shares at the offering price of \$4.00 per share.

The complaint alleges that, throughout the Class Period, Defendants made materially false and/or misleading statements, as well as failed to disclose material facts about the company's business, operations, and prospects. Specifically, Defendants misrepresented and/or failed to disclose that: (1) social-media based misinformation and people impersonating financial professionals created a fraudulent promotion scheme to manipulate the market around *Smart Digital*'s initial public offering; (2) insiders and/or affiliates used or planned to use offshore accounts to coordinate a share dump; and (3) as a result of the foregoing, Defendants' statements about the company's business, operations, and prospects were materially false and misleading and/or lacked a reasonable basis at all relevant times.

THE LEAD PLAINTIFF PROCESS:

The Private Securities Litigation Reform Act of 1995 permits any investor who purchased or acquired *Smart Digital* securities during the Class Period to seek appointment as lead plaintiff in the *Smart Digital* class action lawsuit. A lead plaintiff is a representative party that acts on behalf of other class members in directing the litigation. In order to be appointed lead plaintiff, the Court must determine that the class member's claim is

typical of the claims of other class members, and that the class member will adequately represent the class. Your ability to share in any recovery is not, however, affected by the decision whether or not to serve as a lead plaintiff. Filling out the online form above or communicating with any counsel is not necessary to participate or share in any recovery achieved in this case. Any member of the purported class may move the court to serve as a lead plaintiff through counsel of his/her choice, or may choose to do nothing and remain an inactive class member.
