KTMC SECURES CLASS CERTIFICATION FOR INVESTORS IN INVESTOR LAWSUIT AGAINST INOVALON



A Delaware chancellor has certified a class of Inovalon Holdings common stockholders who challenged the \$7.3 billion

go-private sale of the company to Nordic Capital and claimed Inovalon failed to disclose that the investors who bought it paid \$400million in fees to its financial adviser before the transaction.

In a Monday order, Chancellor Kathaleen St. Jude McCormick signed off on the plaintiffs' stipulation and granted class certification in a lawsuit by City of Sarasota Firefighters' Pension Fund, Steamfitters Local 449 Pension Fund and Steamfitters Local 449 Retirement Security Fund related to Nordic Capital's purchase of the healthcare data company.

KTMC CLINCHES CLASS CERTIFICATION FOR GOLDMAN INVESTORS IN 1MDB BRIBERY SUIT



New York federal judge on Thursday overruled objections raised by Goldman Sachs and fully adopted a magistrate judge's recommendation to

certify a class of Goldman investors who claim losses from the 1MDB bond bribery scandal.

U.S. District Judge Vernon S. Broderick issued an opinion and order adopting U.S. Magistrate Judge Katharine H. Parker's report and recommendation from April that suggested granting certification to all persons and entities that purchased or acquired Goldman's common stock between Dec. 22,2016, and Nov. 8, 2018, and were injured.

Goldman objected in May to Judge Parker's report, saying she erred in concluding that its stock price was affected by the bank's alleged misstatements. However, Judge Broderick disagreed.
